NU was able to get the waterline to hold pressure and initiated a pressure test. While the water line was pressure testing NU was grouting the storm pipes in Cl-1

Northern concluded their water test at 2:20. The pressure test passed with an allowable leakage of 15 ozs NU's testing apparatus dropping from 206-199 only leaked 8ozs
